B'nai B'rith Perlman Camp is proud to provide financial assistance to camp families. Allocations are based on the reality of individual family needs, and we will do our best to address each family's individual situation.

All information is treated with the strictest confidentiality and we take the security of your personal information seriously. Financial Aid applications will be accepted on a rolling basis, and the financial aid committee will meet in **December** and **March** to review completed applications.

The financial aid committee will make a conditional award for your child, which will be reviewed after the submission of your tax forms. *We reserve the right to substantially change your conditional award if there is a significant discrepancy between your completed application and your income tax and wage information.*

The deadlines for submission of the application are November 15th, 2015 and February 14th, 2016.

All Early Bird Families MUST have their completed applications submitted by the November 15th deadline.

After the February deadline, remaining scholarship dollars will only be available to new camp families.

How to Apply for Financial Aid:

1. Apply for camp at www.perlmancamp.org, and choose the Financial Aid session option for the dates you would like to attend. Register with a \$250 deposit to hold your space.
2. Fill out this application completely (on your computer). Submit the completed application via email to jake@perlmancamp.org by saving as a PDF file.
3. Submit your 2014 and 2015 Federal Tax forms (first two pages of each), and 2014 and 2015 W-2 and 1099 forms. Submit via email (preferred), or contact us if you plan to fax or mail to our office.
